Update on Food Labelling Regulations

Allergic Living magazine, Anaphylaxis Canada, the Canadian Celiac Association and the Allergy Asthma Information Association continue to work with the food allergy and celiac communities regarding the lobbying efforts to urge the federal government to approve the proposed food labelling regulations. As you may have seen last weekend, several media outlets reported that the beer industry has come out in strong opposition to the proposed regulatory changes. This opposition by a powerful private interest group threatens to derail final approval of the proposed changes by the federal government.

Community stakeholders have been waiting for 2 1/2 years for these regulations to be enacted - and this is on top of the 10-year campaign for such changes that preceded it. If you are also concerned that your clients with food allergies will continue to be harmed if these life-saving food labelling regulations are not passed, you can demonstrate your support for food labelling changes.
